- 1. Treasurer's Report/Financials Catherine Green (CG)
  - a. Bank Balance: \$47,199.19 operating acct, \$50,946.72 in reserve acct
    - i. Receipts in \$22,900 this year so far, paid bill \$12,906.73
    - ii. AR approx. \$11,461.03
- 2. Approval of the Treasurer's Report: (CG)
  - a. Motion Lot 74 moved, lot 76 2<sup>nd</sup>, all approved
- 3. Approval of the 2025 & 2026 Budget with Contingency Reserve needs to be listed as an asset (CG)
  - a. Contingency Reserve should be listed as an asset
  - b. Need to add weed control to the budget

- 1. Weed Control, we are working with Teller County Conservation District (LS)
  - a. Trying to get 2 applications this year.
- 2. Slash/Trash Day at Transfer Station (CG)
  - a. Spent \$4,524 this year 44 loads of trash
  - b. Spent \$1,380 this year on 69 loads of slash
  - c. Update On-Site Chipping (LS)
- 3. Pond Stocking & Health Analysis (ST)
  - a. Stocked twice with fish for fishing and carp for weed control
    - i. 15 grass carp to handle the weeds.
- 4. Maintenance of Recreation Area (LS, ST)
  - a. The recreation area is insured under the insurance policy.
  - b. There is a reserve for the updates to the pond.
  - c. Looking into a path to the edge of the water, requires wetlands consultation, etc. in process.
- 5. Communication
  - a. Possible presentation by Northwest Fire Department on Fire Mitigation and Protection
  - b. Possible presentation by DOW on animal activity and good owner ideas, tactics, and advice.

- 1) Governing Documents update to meet the Colorado Statues relating to the Colorado Common Interest Ownership Act (CCIOA) (JD) to present status.
  - i. The board engaged an attorney Michael Connelly, Esq. with Willis & Connelly, P.C. to get our governing documents in compliance with CCIOA.
- 2) Election of Officers (ST)

        - a. Moved to add Scott O'Neill to the FPOA board; lot 29, 2<sup>nd</sup> lot 314, all approved
    - ii. CG as Treasurer expires Dec 2025
      - 1. Moved to allow CG to return as board member lot 170, 2<sup>nd</sup> 3, all approved, one person opposed.
    - iii. JD secretary term expires 2027
    - iv. ST second year as VP term expires 2026
    - v. LS as Member-At-Large expires 2028
    - vi. Requested volunteers who might be interested in being on the board.
- 3) Question on short term rentals. Any questions or concerns need to be addressed to Park County.
  - a. No fires period with short term rentals.
- 4) How are issues at the bathrooms at the pond going?
  - a. Bathroom have combination lock access, lock number same as entrance to pond combination
- 5) No snowmobiling in the area
