Status of liens

3 Lots paid 2014 delinquencies. Lien past due accounts, no legal fees on \$25.00 late fees, release liens on cures prior to end of 2014. Assess legal fees on all other delinquents and build in Attorney fees to get block amount.

Kathy – filling on anyone owing less than \$200.00 is too soon. Jude – file on accts at \$200.00 not before. Kyle asked if a pre-file warning letter is sent. Jude – yes. Bob – we should readdress the policy after February.

Kyle- Out Lots and identifying boundaries, trails, etc. Discussed under New Business.

#### Old Business:

- Update: Blue Stem trailer; Coil Drive property w/violations; slash pile on Foxtail-Trent
  - (1) Blue Stem trailer Bob received response from County, they have amended code to ignore trailers and does not see them as an eyesore, is in decent condition and therefore is not abandoned. Kyle stated that the trailer has been there for 14 years and is occupied every 2 years. Bob The board has no good phone numbers for the property owner and they are current on their dues. Bob & Kathy send letter updating homeowner that effective June 1, 2015 fees will be assessed for storage. Trent get legal to advise if the Board can do this. Jude identify lots with trailers and write letter informing owner of rules and upcoming policies for storage fees. Janine we need a policy that has been approved by Legal counsel before we do anything. Allyn or just drop it since the County does not care. Bob Table discussion to March meeting.
  - (2) Coil Drive Property. Janine: Fence no authority, Paint only hazmat depending on quantity (must be a very large amount), Boat must be stored on property not in right of way. Monte spoke with owner and stated that he was embarrassed about the way the property looked.
  - (3) Slash pile on Foxtail. Cleaned up substantially and construction is finishing up and getting taken care of.
- Update on info from Park County regarding building permits-Trent

Can be downloaded in a pdf format monthly free. 2014 – 20 applications, 9 permits issued.

Web site, domain name, and web master-Bob

Go Daddy host and domain. He has access to it. Recommends move and rebuild, this will cost less and can manage board emails. Format is word press, has a contract for \$930.00 to rebuild website. Previous bid was \$1000.00 to \$1500.00.

Status of work at the Pond-Bob

Bob asked to flag willow to extend fence to existing buck and pole fence and estimated the cost at \$1400.00. Board decided to table until spring.

Clarification on check-signing policy-Bob

2 signatures required. Jude – should we be bonded, Allyn – no. Allyn agrees to 3 blank checks for emergencies with dual signatures.

## **New Business:**

Discussion and approval of 2015 Budget

Budget is balanced with a small amount going into reserves. Approved unanimously.

Proposal to identify common areas to guide community usage

Jude – contacted local surveyor. Received proposal to locate all Out Lot pins and stake them except Out Lot E. Proposal not to exceed \$400-\$500. Janine – money well spent and it will be a legal document since it is being prepared by a licensed surveyor. Discussion – we mark with painted rock next to stake. Bob - Motion to accept with not to exceed \$550.00 and must be complete by July 15, 2015, Trent seconded. Passed unanimously.
